**1. Consider Dallas County F.Y. 2002-2010 Trails Project Funding Project**

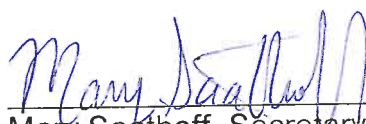
Ann Bagley presented the outline of the Trails Project Funding Project and Grant process. The Board discussed and considered the grant and recommendations.

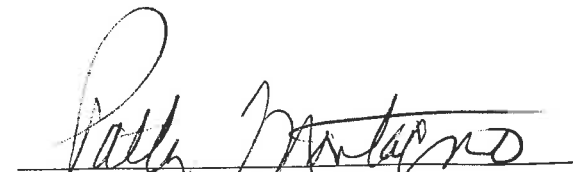
