- 1) The minutes from the May 21, 1996 meeting were read and approved.
- 2) It was decided there would not be a July meeting of the Park and Recreation Commission due to the fact that two members would be out of town, a third member was not pursuing another term on the commission and the City Council had not sworn in new members to fill the vacancies on the commission.
- 3) City Manager Lloyd Henderson briefed the commission on the proposed Parks & Recreation 96/97 Budget. It was noted that the city staff was providing a way to fund the City's part of a applied for State grant. These funds would cover the improvements sought for the 36 acre Park near the Sewell Elementary School.
- 4) City Manager Lloyd Henderson also briefed the commission on the City Council's consideration of a possible bond election on August 10, 1996. Issues most likely to be included on a bond ballot are land acquisition and plans for the construction of a new city hall and animal control facility plus the purchase of land for thoroughfare, right of way and for future park use.
- 5) The commission thanked Virginia Long for her service and dependable attendance on the Park and Recreation Commission since she was not perusing another term on the commission and this was her last meeting.
- 6) With no further business to conduct the meeting was adjourned.
