1. **Call meeting to Order:** Mr. Ronnau called the meeting to order at 7:00 pm.
2. **Roll Call:** At roll call, a majority of the Sachse Economic Development Corporation Board of Directors was present and a quorum was constituted. Ms. Covington and Dr. Parish were absent.
3. **Approve Minutes of April 9, 2008:**
Mr. Denney made a motion to approve the minutes of the April 9, 2008 meeting. The motion was seconded by Mr. Smith and passed unanimously.
4. **Public Hearing: regarding amendment of the Sachse Economic Development Corporation 2007 - 2008 Budget:**
At 7:02, Mr. Ronnau opened the Public Hearing. The Executive Director and the Board of Directors reviewed the budget amendment. There were no other comments from the audience.
At 7:04, Mr. Denney made a motion to close the Public Hearing. The motion was seconded by Mr. Smith and passed unanimously.
5. **Consideration and action regarding Resolution #080514, a resolution amending the Sachse Economic Development Corporation 2007 – 2008:**
Mr. Smith made a motion to adopt Resolution #080514, a resolution amending the Sachse Economic Development Corporation 2007 – 2008. The motion was seconded by Mr. LeMaster and passed unanimously.
6. **Consideration and action regarding request from Stepping Stones Learning Center for 4B Economic Development Grant for property located at 5804 Billingsley Street in Sachse:**
The Board of Directors and property owner, Bobby Tillman, reviewed the project that would include parking improvements. After discussion, Mr. Denney made a motion approve the request with standard terms in an amount not to exceed \$10,000. The motion was seconded by Mr. Saxon and passed unanimously.
7. **Consideration and action regarding formation of Stakeholder Meetings for the SEDC Marketing Plan:**

Tom Stellman, with TIP Strategies, gave a presentation on the status of the SEDC Marketing Plan. The Board of Directors and the Executive Director discussed the formation of stakeholder or focus groups. No action was taken on this item.

8. Update regarding SEDC Website:

Colby Nate, ELevel, and the Board of Directors reviewed the website. The Board of Directors asked questions and made comments. No action was taken on this item.

9. Update on Form Based Code:

The Executive Director gave an update on the form based code project. No action was taken on this item.

10. Reports:

Executive Director –The Executive Director reported on the status SEDC Projects.

11. Citizen Forum: There were no comments from the audience.

12. Adjournment: There being no further business, Mr. Smith made a motion to adjourn. The motion was seconded by Mr. Saxon and passed unanimously.
