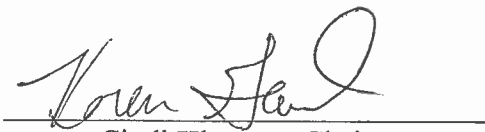

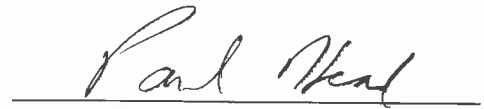
Action:
