Call to Order

The meeting was called to order at 7:00 PM.

Mr. Whitworth reported that we currently have \$122,114 in Park Development Funds. This means that we don't have to wait for EDC funds to move forward with beginning the development of Firefighter's Park. The board can discuss at next month's meeting on what they'd like to start on and then staff will go to the City Council to request use of those funds.
