

**LIBRARY BOARD OF THE CITY OF SACHSE
MAY 11, 2026, MEETING MINUTES**

The Library Board of the City of Sachse held a regular meeting on Monday, May 11, 2026, at 7:00 PM at Sachse City Hall, 3815-B Sachse Road. Those present were: Shanna Conde, LaWan-Dia Rhoden, Meghan Kershaw, Betsy Urschel, Rafay Sheikh.

Those absent were: Allyssa Loya, Adashea Dugan.

A. Regular Meeting

1. Call to Order: The Library Board of the City of Sachse will hold a regular meeting on Monday, May 11, 2026, at 7:00 PM to consider the following items of business:

Chairperson Conde called the meeting to order at 7:09 PM.

2. Invocation and Pledge of Allegiance to the U.S. and Texas Flags.

Ms. Urschel offered the invocation and Ms. Kershaw led the pledges.

B. Public Comment

The public is invited to address the Board regarding any topic not already on the agenda for action or public hearing. **Comments regarding any discussion-only items on the agenda may be addressed during this Public Comment section.** The time limit is three minutes per speaker. A Public Comment Card should be presented to the acting secretary prior to the meeting. According to the Texas Open Meetings Act, the Board is prohibited from discussing any item not posted on the agenda but will take comments under advisement.

No public comments were offered.

C. Action Items

Action items are for Board discussion and consideration for action. **The presiding officer will invite comments before the Board votes.** A Public Comment Card should be given to the acting secretary prior to the start of the meeting.

1. Consider approving the April 13, 2026, meeting minutes.

Ms. Rhoden made a motion to approve the minutes as presented. Ms. Kershaw seconded the motion, and it carried 5 - 0. None voted against.

2. Consider approval of the Library Computer Use Policy.

Ms. Urschel Made a motion to approve the Library Computer Use Policy as presented. Mr. Sheikh seconded the motion, and it carried 5 - 0. None voted against.

D. Discussion Items

These items are for the Board and staff to discuss as needed. **Comments on Discussion Items should be addressed in the Public Comment Section of this meeting.**

1. Receive and discuss the Library Manager's monthly report.

Mr. Cross presented the monthly report and statistics for the Library. He noted increases in many areas, such as door count, program attendance, circulation, and library card applications. He explained the variance in books being shipped and delivered, and in some continuing issues with items being shipped to the library from the vendor.

There was a discussion on the increase in library users and the impact on service and availability of items in the collection.

2. Discuss Library Board announcements regarding special events, current activities, and local achievements.

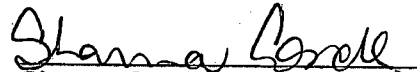
Mr. Cross announced the Library's upcoming activities and the proclamation by the Mayor for National Library Week. He gave an update on the Library audio system.
