- Discussed Water Fountain: Deadline to finish November 20.
- Park adjacent to schools: Cities of Sachse & Garland ISD are in agreement. Attorneys holding up, due to disagreement. Football field contract is finished.
- Muddy Creek: engineering firm under consideration for survey. Surveying still under consideration. Still in land acquisition stages. 235 acres, could be more if land owner decides to sell.
- City Council: Still considering Bond Issue.

 - (b) Construction of 27 acre park

Marshall A. asked about Grant on Miles Road Bicycle Trail. Funds will not be allocated until February 1994.

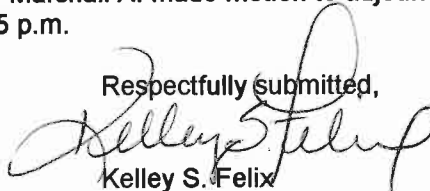
- 3) Fallfest Association Fund Distribution.

Paul B. & ^{Kelley} Kelly F. complained about conditions of Ballpark Restrooms and trash pick-up. ^{Kelley} Kelly F. asked about status of absent Park Board Member, Bonnie Hanslip.
