4. Future Park Site:

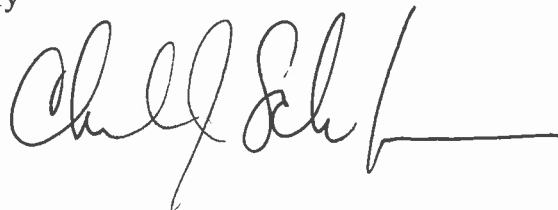
Chairman had requested information on the Dewitt Flood Plain park site from City Manager Lloyd Henderson for the commissions consideration.
